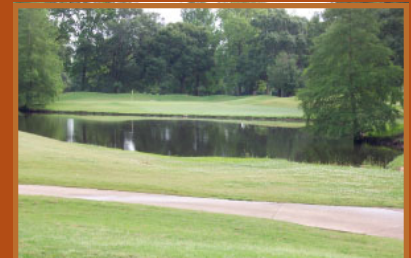

Since 1909, golf greats such as Walter Hagen, Ben Hogan, Tommy Bolt, Emilyn Aubrey, Meredith Duncan, John Daly, David Toms, Hal Sutton and Shreveport's own Perry Moss have graced their fairways.
